**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY, AND PARENTAL  
CONSENT AGREEMENT ("AGREEMENT")**

In consideration of participating in the (Houston County, Ga) The Middle Ga Fire Truck Pull to benefit the HALO Group of Middle Ga.("Activity"), I represent that I understand the nature of The Middle Ga Fire Truck Pull events and that I and/or my minor child am qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I and/or my minor child believe event conditions are unsafe, I and/or my minor child will immediately discontinue participation in the Activity.
