Ms. Kimberly K. Herren is the Director of 638th Supply Chain Management Group, 448th Supply Chain Management Wing, Air Force Sustainment Center, Robins Air Force Base, GA. She is responsible for enterprise-wide planning and execution of the Air Force Supply Chain. Her responsibilities include sustaining weapon systems worldwide by providing supply chain life cycle support to include developing enterprise demand/supply plans, developing/ implementing sourcing strategies, executing the supply plan, and executing cognizant design engineering authority to meet customer requirements. Her supply chain management portfolio consists of repairable items for avionics, electronic warfare, armament, support equipment, vehicles, and automatic test equipment. Also, included are structural and avionics peculiar items for the C-5, C-130, F-15 and Special Operations aircraft. Ms. Herren is also responsible for financial oversight of \$2.3 billion annual cost authority, and providing policy, guidance and support for supply chain management in order to provide the greatest support to the warfighter.



Ms. Herren has over 34 years of logistics and program management experience. She began her federal civilian service career at Robins Air Force Base, GA, in 1986 as an Item Management Trainee in the C-141 System Program Office, Warner Robins Air Logistics Center. After 10 years of supply chain experience, she broadened into the program management career field and went on to hold various branch and division level positions in the C-130 Program, Maintenance Training, Center-level plans and programs offices. In 2010, Ms. Herren returned to supply as the Director of the 407th Supply Chain Management Squadron, 638th Supply Chain Management Group, 448th Supply Chain Management Wing, and Air Force Sustainment Center. Prior to assuming her current position, she was the Deputy Chief of the Command and Control, Intelligence, Surveillance, and Reconnaissance Division, Battle Management Directorate, Air Force Life Cycle Management Center, Robins Air Force Base, GA.
